TAYLOR'S DAY stalked the winner into the lane, bid near the eight pole then flattened. LIFE SAYVER raced in the three path through the turn, fanned five wide into the lane then lacked the needed response. NATURAL ENEMY raced in the five path through the turn then flattened in the lane. ONLY JOE chased the pace from between rivals then tired in the lane. GROOVY ZONE raced between rivals through the turn then faded. U B THE JUDGE was outrun from the three path. T BOY was outrun from along the inside.
