SUPERIOR COURT was unhurried early, angled five wide into the turn then rallied in the stretch and drove past the leader inside the eighth pole and opened up under a brisk drive. ALEXANDER'S BELLE chased the pacesetter to the turn then angled off the rail into the turn and moved up in the stretch while no match for the winner. PAIGES PEBBLE raced up close early then while making a move for contention steadied inside to be shuffled back, angled four wide into the turn with no final gain in the stretch. ROYAL ORO was back early, angled five wide into the turn and improved position in the stretch run. MISS AMBER angled four wide into the turn while no threat. HUATUSCO tracked the pace from the inside, angled off the rail into the turn with no rally in the stretch drive. LADY TALKING set the pace for a half while on the inside into the turn then ran out of gas in the stretch run. ROUND NATIVE MISS stumbled at the start, angled six wide into the turn while no factor. SEA OF ARCHES was never involved. DEVILISH CANDY stalked the pace from the outside, angled four wide into the turn and soon retreated.
