STORM IN THE LAKE stalked the pace early, angled into the three path in the turn then took over command in the stretch and drew away late under a steady drive. WHY PRETEND was unhurried early, angled into the four path in the turn with a mild gain in the stretch run. RIVRAV tracked the pace from the inside, stayed on the rail into the turn and weakened late. KEEN CASE was well placed early, angled into the three path in the turn and faded late. FLYING PETER set the pace early, angled off the rail into the turn and gave way in the stretch. BLUE RIGHT BY bobbled at the start and was no factor.
