LAWYER BROCKMEYER was allowed to settle in the early going, rallied four wide on the far turn then was in a strong drive in the stretch and was best in the end. YESTERDAY stalked the pace while racing three wide then rallied on the far turn, gained a slim lead in mid stretch but came up empty in the end. PITON set the pace from the start, drew off heading into the far turn then was in a long drive but weakened in late stretch. TUDIE POP was allowed to settle in the early going, saved ground on the far turn making a bid but came up empty in the stretch driver. DREAMING OF TAYLOR was unhurried early and angled to the inside, raced inside on the backstretch then made a mild rally in the stretch but was no menace. SEAMSTRESS was stalking the pace while racing three wide on the backstretch, was blocked behind rivals entering the far turn then was no menace in the stretch. MOTION TO DISMISS was unhurried early then moved out to be eight wide for the stretch drive but was no factor. LAN LAN was void of early speed then raced four wide on the backstretch but was no factor in the stretch. SWEET BET was unhurried early then fanned out to be seven wide for the stretch drive but was no factor in the end. RIVA'S DISPUTE pressed the pace while racing two wide, was used up then stopped in the stretch.
