STAKES Crown Ambassador S. Black Type - Thoroughbred
 (INCLUDES UP TO \$42,000 ITDF) FOR REGISTERED INDIANA BRED TWO YEAR OLDS, Sired by Registered Indiana Stallions. COLTS AND GELDINGS PREFERRED. By subscription of \$50 each, which shall accompany the nomination \$200 to pass the entry box and \$100 additional to start, with \$84,000 added. Supplementary nominations may be made by the usual time of closing of entries for a fee \$840 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, the remaining purse will be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Weight: 122 lbs. Non-winners of a sweepstakes allowed 2 lbs; of two races other than maiden or claiming, 4 lbs; of one race other than maiden or claiming, 6 lbs; maidens, 8 lbs. Starters to be named through the entry box by the usual time of closing. This stake will be limited to twelve starters. If more than twelve horses pass the entry box, preference will be given to (1) Colts and Geldings; (2) High Weights (sex allowances considered); (3) Highest Earnings will then be used in determining the order of preference of horses assigned equal weights. The entry fee will be refunded if a horse fails to draw into the race. (S)

DREAD THE PIRATE dueled early, angled off the rail into the turn then drew away late in the stretch under a steady drive. CLYDE PARK stalked the pace early, angled into the four path in the turn then made a bid in the stretch but weakened late in the drive. SEAL BEACH was unhurried early, angled into the four path in the turn and moved up in the stretch drive. SHORT ROUND tracked the pace early, angled into the four path in the turn then made a bid in the stretch but flattened out late. GOOD GRIEF was back early, angled into the four path in the far turn with a belated gain in the stretch run. ERIN'S CHARGE dueled early, while on the inside into the turn and gave way in the stretch. PAINTED VALLEY was done early. CITI RUSH was through after a half. KILLENAULE GREENE steadied and checked into the turn. JOINT TENANT showed little. NEEDMORE CASH was outrun. HUNK A PIE had early speed then folded up.
