

SAILORS PASTTIIME stalked the pace three wide, bid on that path into the stretch, drifted in in the lane and tired. NA KELLY set the early pace inside, tired. SHEZA JUSTICE showed little. SCOOTINIT was no factor. PLEASANT SMILE was outrun.
