### Footnotes

RIDGEWAY ANGEL pressed early then took over command, angled off the rail into the turn and drew away late in the stretch under a steady drive. THUNDER CHICKEN stalked the pace early, angled into the four path in the turn, made a bid in the stretch but weakened late. GAELIC LASS was well placed early, angled into the five path in the turn and moved up in the stretch run. IROQUOIS MISS was back early, angled off the rail into the turn and improved position. DREAM DATE DIVA chased the pace early, angled into the three path in the turn and faded late. ZONE was never a threat. STRIVING tracked the pace early, angled off the rail into the turn and was empty in the stretch drive. TAPITFORPAR was through after a half.
