WILD TUMBLE set the pace inside, shook clear in the stretch, increased her lead while drifting out and lasted under steady pressure. DA HIGH WATER well back, moved up slightly through the turn, fanned five wide into the stretch, then altered widest for clear racing room and closed fast to get up for the place. FROSTING vied for the early lead outside, could not go with the winner into the stretch, stayed on to hold the show safe. HOOSIER STEPS mid pack and off the rail, moved up quickly four wide into the turn, angled in slightly through the turn, then fanned five wide into the stretch and could not gain the final furlong. MARCHINI tracked the pace inside, angled out to bid four wide into the stretch and weakened the final furlong. RACIN JUSTICE well placed and between rivals, dropped back through the turn, came through inside of rivals into the stretch and had a mild gain. KIM'S SHINE improved her position. EASTER DELL well placed and outside, dropped back through the turn and ran evenly. CARISSA K was never involved. SUITE FAITH was no factor.
