SHERRY'S TIGER set the pace early, then came in slightly in the turn, angled off the rail inside the quarter pole then drew clear in the stretch under a steady drive. SHINY STAR tracked the pace early, angled into the four path in the far turn then made a bid in the stretch but flattened out in the final stages. OH MY SWEETIE PIE was well placed early from the inside, steadied into the far turn, angled off the rail inside the quarter pole then made a bid in the stretch run but hung late. LET'SPLAYGORGEIOUS chased the pace early, angled into the four path in the far turn and weakened late. FLASH GOLDEN was on the inside into the far turn and moved up in the stretch run. MONKEY DUST angled into the four path in the far turn and improved position late. VERDANT stalked the pace early, angled off the rail into the far turn and faded late. BOLD PEAKS was through after a half. STRAWBERRY'S HEART was done early. GERI ROAD was pulled up and vanned off. AFTER A RIDERS OBJECTION BY THE RIDER OF OH MY SWEETIE PIE, SHERRY'S TIGER WAS DISQUALIFIED AND PLACED THIRD FOR INTERFERENCE IN THE FAR TURN.
