Footnotes

SMOKIN SILVER tracked the early pace inside, waited through the turn, got through inside of rivals at the quarter pole, dueled with ITS A DEAL through the lane, drove clear late. ITS A DEAL broke sharply to set the early pace off the rail, dueled with the winner through the lane and was outfinished in the late going. BE BY ME tracked the early pace outside, came three wide to bid into the stretch, then lacked the needed late response. BULLNOSE BRICK well back and outside, fanned five wide to bid into the stretch, then got up for a share in the late going. PULASKI COUNTY well placed in the early going, angled out to four wide to make a middle move, bid on that path into the stretch, flattened out. I'M WEALTHY showed little. STAGE STREAM bobbed at the start, could not get in stride and was outrun.
