Footnotes

PICO SUAVE tracked the pace early, angled into the three path in the turn then made a bid in the stretch and edged clear late under a steady drive. SAHMMY DAVIS JR set the pace early, while on the inside into the turn then drew clear in the stretch but yielded late in the drive. NORTHERN REVEAL chased the pace early, angled into the four path in the turn and weakened late in the stretch drive. MAN FROM MARS was well placed early, angled into the three path in the turn and moved up in the stretch run. FATHER JOHN pressed the pace early, angled off the rail into the turn and faded late in the stretch. MOONSHINE STILL was unprepared at the start, angled into the five path in the turn. MISTER MOORELAND was through after a half. SEAPOPS was never involved. LAWYER DAGGETT showed little. DANDY SANDY was done early.
