### Footnotes

PHAT DAY was allowed to settle while racing two wide into the turn, rallied then moved out to be five wide in the stretch drive, was gaining ground strongly and was up in the final stride. ONLY WIN dueled for the early lead while two wide, was in a long drive and was all out in deep stretch but was caught in the final stride. SOLD OUT dueled for the lead while inside, was hard used on the turn then faltered in late stretch. DOLLAR YO broke in the air at the start then was settled, made a mild rally in the stretch then fell suddenly just after the wire and was van off. MOMENTS NOTIZ was inside on the turn then failed to respond in the stretch drive. REDDICK TOWNSHIP was unhurried early and racing on the inside on the turn but failed to menace. TALBOT was unhurried early then was no threat. DALAMAR raced three wide into the turn, was used up and gave way in the stretch drive.
