OUTFNOWHERE pressed the pace from the outside, then rallied on the outside to gain command in upper stretch, drew off then was all out to finish on even terms with MADAM PERSUASIVE at the wire. BRIEF VALENTINE stalked the pace while three wide, made a bid on the far turn then faltered in the stretch drive. EMMARIA dropped back on the run down the backstretch then lacked a rally when asked. SUPRIZED raced three wide on the backstretch then failed to menace. LAMPSAS COUNTY on the inside and faltered in the drive.
