HEY RED vied for the lead from the inside, was in a long drive on the turn and stretch, dug in gamely and prove best in the end. STROBE LIGHT vied for the lead while two wide, was in a long drive and gamely dug in throughout the stretch drive but tired in late stretch. ZARCO was unhurried early then swung out and circled the field while eight wide and was gaining ground to finished well. CANTERBURY TAIL was settled then rallied on the turn while six wide, made a bid but came up empty in late stretch. STORM TUNER was two wide on the turn then was steadied off heels at the quarter pole, rallied two wide in the stretch and was gaining ground but was no menace. GOLD COUNTRY CAT was saving ground on the turn then rallied two wide in the stretch but was no menace in the stretch. MY DESTROYER was unhurried early then rallied on the turn and swung out to be five wide in mid stretch and mild gain in late stretch. B G TOP YANKEE was settled the rallied six wide on the turn making a bid then flattened out in the stretch drive. MARBLE ARCH was unhurried early and raced five wide on the turn then made a mild rally in the stretch. SONG OF THUNDER was inside and pressing the early pace, was shuffled back in the turn then lacked a rally in the stretch. TODDS STORM was three wide heading into the turn then was in tight quarters nearing the quarter pole then dropped back in the stretch. OKIE NATION vied for the early lead while racing five wide, was used up then stopped in the stretch. JAGGED EDGE vied for the early lead while four wide, was hard used then stopped. STEALIO showed brief speed while racing five wide and stopped on the turn.
