NAEVUS GIRL was never far back while racing on the outside, rallied in the upper stretch four wide, drew off late under left handed urging. RIGHT TO RULE well placed and saved ground, finished willingly and held place. SEA OF DREAMS dueled while between horses, just missed second in a good effort. G RATED unhurried early, had a mild bid while no threat. IMPERIAL POMEROY dueled while between horses, weakened in the stretch. CATALE WIND dueled early on the inside, steadied on the turn, weakened in the stretch. AMOZAN RULER raced middle of the pack, lacked a late response. TIGER'S SPLENDOR well placed, had no rally. WILDCAT CALLIE was no factor. IMMA BE A WILDCAT took a bad step down the backside, lost her rider and was vanned off. The stewards posted the inquiry sign but took no action.
