**Footnotes**

DANZIGCA set the pace under pressure, relinquished the lead with three furlongs to run, dueled with CLOSE CLEARANCE in upper stretch, disposed of that rival passing the furlong marker and drew away while ridden out. CLOSE CLEARANCE was bumped at the start, pressed the pace on the inside, took the lead with three furlongs to run, dueled with the winner in upper stretch and proved no match for that rival while clearly second best. VERMONTS HARMONEY raced three wide on the first turn, tracked the pace on the outside, dropped back on the far turn and bested the rest. SHERIZOD bobbed a tad at the start and bumped with CLOSE CLEARANCE, saved ground while near the back of the field and failed to threaten. RAINY DAY ROMANCE raced well back in the field, went four wide on the far turn and never reached contention. SEATTLE MAJESTY raced three wide on the first turn, settled towards the rear of the field, passed rivals while saving ground on the far turn but also never reached contention. EVRSTRIVE EVRSHINE settled on the inside, shifted out midway down the backstretch, raced three wide on the far turn and failed to respond. SMART APPEAL was caught four wide on the first turn, settled on the outside while just off the pace, dropped back while hard ridden on the far turn and stopped.
