ROAR AWAY was well rated while setting the clear pace, remained clear into the final furlong and held sway under good handling. SUPERCCELL was forwardly placed on the inside, came under a ride while continuing to save ground on the far turn, battled determinedly in the stretch but missed. A R CRACKERS settled while off the pace, was urged along while between rivals on the far turn and lacked the needed kick while able to secure the show. SIR RABBIT settled off the pace, steadied outside the furlong marker and lacked the needed rally. AFTERNOON PUNCH raced three wide on the first turn, settled behind the solo leader, chased that rival on the far turn and came up empty. VINEGAROOON was reserved on the inside, saved ground into the stretch, moved out inside the furlong marker then bumped SHILOH BOUND and failed to menace. SHILOH BOUND raced three wide on the first turn, lingered towards the rear of the field, remained well back into the stretch, was bumped inside the furlong marker and failed to threaten. LAURA'S CHOICE raced three wide on the first turn, bumped with MEET DR MIKE leaving the chute, lagged at the rear of the field, went four wide on the far turn and was no factor. SPEND A WEB raced four wide on both turns, dropped to three wide entering the stretch and showed little. FAST ON FRIDAY settled off the pace, waited at the back on the far turn and never reached contention. MEET DR MIKE bobbed at the start, bumped with LAURA'S CHOICE leaving the chute, raced four wide on the first turn, settled well off the pace, went three wide on the far turn and showed little. UNRULY raced three wide on the first turn, settled in the middle of the field, was urged along while three to four wide on the far turn and dropped out. (Rail at 0 Feet)
