RED MOON CAT was unhurried early then rallied on the far turn, moved out to be five wide in upper stretch, was in a strong drive and proved best in the end. OFFICE MORGAN was unhurried early then rallied on the far turn three wide, moved out to be six wide for the stretch drive, closed willingly in late stretch and finished well. WHY'S THAT showed early speed from the inside, was taken back off the pace, stayed inside and saved ground on the far turn, rallied along the inside in the stretch making a bid but came up empty in late stretch. BUENA FORTUNA (MEX) was settled on the run down the backstretch while racing two wide, was blocked nearing the top of the stretch then moved to the inside coming out of the turn, bid then angled out to be three wide and closed willingly in late stretch. READY LOVE was allowed to settled then rallied on the far turn while three wide, moved up to gain the lead in mid stretch but failed to sustained that bid in the end. MIRACLE LAKE stalked the early pace while racing three wide, gained the lead then drew odd while in a long drive but weakened in the stretch. CAROL'S FRIEND was unhurried early while inside, rallied then swung out to be six wide in upper stretch but was no menace in the stretch. RAZZDAZZ stalked the early pace while racing two wide, made a bid on the far turn then faltered in the stretch drive. BACK TO HURSTLAND was settled then made a three wide middle move into the far turn but flattened out in the stretch drive. FAPIANO QUEEN pressed the early pace while two wide, moved out to be four wide on the far turn, bore out in the stretch and faltered. A claim of foul was lodged by the rider of OFFICE MORGAN accent the rider of RED MOON CAT for interference in late stretch. After reviewing the films, no action was taken.
