FLAMING STRIKE dueled on the early lead, gained a clear lead at the quarter pole, widened in the stretch to win as much the best while kept to pressure. DIXIE LULLABY broke slowly and was allowed to settle, rallied in the stretch, could not challenge the winner but was second best. HUCKLEBERRY LARRY unhurried early, rallied in the upper stretch four wide with a mild bid. EAST PARK WAY allowed to settle early, passed tiring rivals. BEFORE TAXES raced middle of the pack and was no threat. GYROBALL pressed the pace for a half, weakened in the stretch. THE DEMON CHILD had good position for a half, gave way in the stretch. TURN TO TEXAS raced wide and was no threat. MIESQUE'S SHADOW slow early, was no factor. BASKET CATCH pressed the pace and was through after a half. STEALIO saved ground and was outrun. JAZZY RAZOR flashed brief foot and gave way. THE RIDER OF HUCKLEBERRY LARRY CLAIMED FOUL AGAINST THE RIDER OF DIXIE LULLABY FOR ALLEDGED INFERENCE AT THE QUARTER POLE. AFTER VIEWING THE TAPE THE STEWARDS TOOK NO ACTION.
