### Footnotes

EXIT was dueling for the lead from the inside while being well handled, drew off in mid stretch and was kept to task in the stretch. HOLIDAY PROMISE was unhurried early then rallied on the backstretch while two wide, rallied then angled out to be five wide in upper stretch then was gaining to be second best. ARTHUR'S COURT was settled then was rushed up while three wide on the backstretch, made a strong bid on the far turn to upper stretch then faltered in the drive. COMPENSATION was settled then rallied while five wide on the backstretch made a bid on the far turn but flattened out in late stretch. HURRICANE DAY was allowed to settled then was shuffled back on the far turn, made a mild rally while three wide in the stretch but was no threat. RIKKI TIKKI TAVI was unhurried early then rallied then swung out to be seven wide in upper stretch and was no menace. CAPTAIN WEBB was allowed to settled then raced inside on the backstretch, made a bid in upper stretch then flattened out in the stretch. ZAPTITUDE was allowed to settled while racing three wide then was squeezed back on the backstretch, dropped back then was no menace. QUIET COMMAND was settled and raced four wide on the backstretch, was in tight in upper stretch and gave way. SALTY RIDGE dueled for the lead while two wide, was used up then stopped.
