SILKY SAMI was unhurried early then started a run heading into the far turn, moved out to be three wide then angled out in upper stretch to be five wide, was in a strong drive in the stretch and proved in the end. BETH'S ANGEL stalked the early pace while racing on the inside, saved ground on the far turn then was in a long drive in the stretch then bore out slightly to brushed with CAJUN FRENCH but hung in the end. CAJUN FRENCH was unhurried early then rallied four wide on the far turn, rallied in the stretch then and brushed with BETH'S ANGEL in late stretch but hung in the end. WARM N COZZY was settled in the early going then rallied four wide on the far turn then made a mild rally in the stretch but was no threat. ZAMITA was unhurried early while racing three wide on the first turn then made a mild rally but was no threat. MIDWAY BLUES set a pressured pace from the inside, was in a long drive throughout then gave way in the stretch. VISION QUEEN was well placed while racing three wide on the backstretch, made a bid on the far turn then faltered in the stretch drive. IDE BET DIXIE pressed the early pace while two wide, was used up then stopped on the far turn. LINDSLEYS GRAY trailed throughout. A claim of foul was lodged by the rider of CAJUN FRENCH against the rider of BETH'S ANGEL for interference in late stretch. After reviewing the films, no action was taken.
