SISTER GENEVIEVE was ridden along while off the pace, saved ground on the turn, squeezed through to make a rail bid entering the final furlong then edged clear under strong handling. DAVID'S SURPRISE dueled on the inside, vied into the final furlong and weakened while able to hold the place. JET G'S COURAGE chased the pace, raced off the rail on the turn and lacked the needed kick while able to get the show. GOLD SPIKE dueled between rivals, vied into the final furlong and tired. MAGIC PLEASURE pressed the pace on the outside, vied three wide on the turn and gave way. STORMIN NICOLE drifted in early, raced three wide on the turn and failed to threaten. ABBEY COURT lacked early speed, raced four wide on the turn and was no factor. ELK CHEEKY saved ground on the turn and was outrun.
