**Footnotes**

STELLA COME BACK dueled on the inside of several rivals, edged clear in upper stretch and proved best under strong urging. IT'S CHILLY dueled between rivals, failed to match strides with the winner in upper stretch and was second best. BOLD RITA was allowed to settle into stride, advanced along the rail leaving the backstretch, lacked room behind rivals midway through the turn, shifted three wide near the quarter-pole, held a good striking position into upper stretch but finished evenly and settled for the show. VACARRI was void of speed and dropped well behind the field, saved ground on the turn, angled out inside the furlong marker and improved position without threatening. WHISPERIN GIRL settled on the outside, raced five wide on the turn, moved to six wide near the quarter-pole and failed to threaten. DANZIGCA prompted the pace on the outside, vied four to five wide on the turn and faded. QUEEN OF THE ISLE dueled between rivals while three wide, moved to four wide near the quarter-pole and tired. SMART APPEAL chased the pace while four wide, dropped out near the five-sixteenths marker and stopped.
