WINDY LOU was settled early on while racing three wide on the backstretch, rallied three wide on the far turn then was in a long sustained drive to take command in mid stretch then was all out to hold sway in the end. MR. CHIPS was stalking the early pace while racing on the inside on the backstretch, rallied coming out of the far turn and swung out to be four wide in upper stretch, was gaining ground to finish well in the end. TAKSENT set the early pace then was shuffled back to stalk the pace on the backstretch, was inside on the far turn then in tight quarters in upper stretch and checked slightly, angled out in mid stretch but hung in the end. GOOSEY MOOSE was well placed while racing two wide on the backstretch, dropped back before the far turn then failed to respond in the stretch when asked. BUBBY BOLT was rushed to the lead while three wide on the backstretch, drew off before the far turn while being used up then faltered in the stretch drive. RARE FLYER was unhurried early then failed to menace in the stretch. PRACTICE TEE was allowed to settle in the early going then failed to respond when asked on the far turn.
