B B QUEEN OF SCAT tracked the pace from outside rivals to bid through the far turn, shook off SAWYOUINADREAM nearing the lane and edged away under steady handling. SAWYOUINADREAM stalked the pace from three wide, moved with the winner through the far turn then could not match strides in the lane. FORTYFIFTHPARALLEL was just off the pace racing three wide, made a mild run from four wide into the lane and narrowly missed the place. BEADED was in reach of the pace racing three to four wide and lacked a solid closing bid. DONNAZERI moved up three and four wide while not a threat. C O PEACE moved to a clear lead early, made the pace out from the rail and tired nearing the lane. ZENA'S AFFAIR came out to bump with a rival at the start and failed to threaten from three wide. DIVI IN TRAINING was not a factor racing out from the rail. HIGH SPEED JUSTICE was bumped at the start, followed the early pace along the inside and tired.
