**Footnotes**

RED HEADED WOMAN moved up three and four wide heading up the backstretch, waited in behind the leaders midway to the far turn, angled out to move four wide in that bend then reeled in FIREWHIRL through the lane to wear that one down and prevail late. FIREWHIRL stalked the leaders from three wide to make her bid into the far turn between rivals, edged clear nearing the lane then could not contain the winner late. MY HOMETOWN GAL stalked the pace from four wide to bid into the far turn and could not sustain the run. WINE TASTING ROOM saved ground in good position to the far turn and weakened. SAFE N RICH moved to a clear lead in the first turn, carried the margin to midway up the backstretch and had nothing left. SWAN'S WING was angled out leaving the second turn but failed to mount a bid. PHOEBE'S TUNE trailed with no apparent mishap.
