Footnotes

RESONATE tracked the pace racing three to four wide, bid between rivals with FASTCUT into the far turn, kicked clear into the lane then held safe late. DON'S BABY lunged at the start to come away a bit slowly, rallied outside through the far turn to fan eight wide into the lane and closed strongly late to be quickly getting to the winner. FASTCUT moved with the winner into the far turn with his bid then lacked the needed late run. OKIE THUNDER saved ground while well back early and moved up along the rail into the lane. CINBUSTER stalked the leaders from four wide and lacked a final closing response. HOOLIGAN broke inward, was a bit tight off a rivals heels into the first turn, moved up while angling out but failed to threaten. YANKEE RULER stalked in good position from along the inside, angled out into the lane and weakened. DOC TANNER moved to the front into the first turn racing off the rail and weakened before the far turn. BEN WON'T TELL lunged at the start, stalked from outside and dropped back while fanned seven wide into the stretch. GRAND CHEROKEE was just off the pace racing three to four wide and tired.
