Footnotes

T JAYS AFFAIR tracked the pace racing four and five wide through the first and second turns, moved in to challenge SPICE SWIRL going to the far turn from three wide, came back out through the lane and offered up a late run to collar that one deep stretch. SPICE SWIRL made the pace on a short lead racing in the two to three path, resisted the winner through the far turn, was moved out a bit in upper stretch then lugged in late and could not last. SOOKIE'S KOOKIES stalked the pace from four wide to move between foes and press the issue in the second turn then could not go with the top pair through the final half mile. SOUNDS BETTER saved ground to the far turn, angled four wide in that bend but had no rally. BLACK AND FANCY tracked the early pace from three wide and tired.
