## **Footnotes**

REACH ONE MORE moved to the front in early going and established position inside while pressured by JUSTABIT SHAWKLIT, continued under a comfortable hold despite being headed in early backstretch then moved clear in the lane under modest urging. JUSTABIT SHAWKLIT forced the pace from outside the winner throughout to put a head in front in early backstretch, remained at that one's flank into the stretch then could not match strides in the final sixteenth while well clear for his position. SUGARDAZZLE broke hard into the side of the gate and bobbled, saved ground for a half mile, angled three wide heading up the backstretch then held his position in the lane while no threat to the top pair. SKWHIRL was angled three wide heading up back the backstretch but failed to make a solid bid. MORTRUMP settled off the leaders racing three to four wide to late backstretch and weakened.
