### Footnotes

MY BAILOUT broke sharply and vied for the lead from along the inside entering the first turn, opened a clear lead entering the final turn, and was able to hold off the closers in deep stretch. SEE EYE TO EYE angled in to save ground entering the first turn, settled well back of the pacesetters into the backstretch, rallied along the inside on the final turn, and closed willingly one from the rail in the stretch drive to get up for the place. RAINBOWSINTHEWOOD unhurried early while dropping back to trail, rallied four wide entering the final turn and closed well from the outside in the lane to just miss the place. GOLDEN RATIO away alertly and eased off of the pacesetters entering the first turn, held a stalking position to the final turn, commenced her rally along the rail to loom the main danger entering the stretch but was outfinished in the lane. HIDDEN HARBOR away well and pressed the pace three wide through the first turn and down the backside, was unable to keep tabs on the winner entering the final turn and weakened in the stretch drive. TICK ME OFF showed no early speed while lagging well back, and failed to menace. R DUBAI GIRL raced mid pack one from the rail in the run down the backside, but faded over the final furlong. SUSAN'S LUCK dueled for the lead from between rivals entering the first turn, chased the pace to the final turn before weakening. Following the running of this race there was a riders claim of foul. The rider of TICK ME OFF lodged a claim of foul against the rider of HIDDEN HARBOR for alleged interference away from the gate. After review the stewards made no change to the original running order
