SUPER STEVE broke sharply, pressed the pace from the inside, gained the lead from three wide on the second turn, drew clear driving. JUMP PASS broke sharply, steadied early, chased the leaders, rallied from three wide and finished well. OLAXSA trailed for the first half mile, rallied from four wide and finished well. CAN'T WAIT FOREVER hustled along, gained command from three wide into the first turn, set a pressured pace, gave way. BRIARTIC COUNTY broke sharply, pressed the pace, was through after the half. Following the race there were two riders claims of foul. The rider of CAN'T WAIT FOREVER claimed foul against SUPER STEVE for interference away from the gate. The rider of JUMP PASS claimed foul against the rider of SUPER STEVE for interference first time through the stretch. After review both claims of foul were disallowed
