UNQUIET away alertly and rushed to a clear lead entering the first turn, increased his advantage entering the final turn and drew off in the stretch. GIMME DATT allowed to settle off the early pace racing one from the rail, rallied two wide from between rivals entering the final turn and closed well through the stretch to prove clearly second best. SHINTOISM unhurried early while dropping back to trail, tipped four wide into the stretch and closed willingly. LUCKY MOLY MINER away well but was forced to check sharply in the early going while in tight at the rail, chased the pacesetter into the first turn from along the rail, tracked three wide down the backside, but faded slightly in the stretch. BRASS AND GOLD showed no speed while lagging well back early, rallied three wide on the final turn and closed willingly through the final furlong. MR JIGSAW chased the pacesetter three wide into the first turn, angled in and rallied along the rail on the final turn but faded in the stretch drive. TIME GOES ON broke sharply but was forced to steady sharply in the early going when in tight quarters, chased the leader into the first turn one from the rail, held a striking position down the backside but weakened over the final furlong. Following the running of this race there were both a stewards inquiry as well as two jockey's claim of foul. The rider's of both LUCKY MOLY MINER and TIME GOES ON claimed foul against the rider of UNQUIET for alleged interference in the run away from the gate. After review the stewards upheld the claims of foul and disqualified UNQUIET from first and placed this horse last for interfering with both LUCKY MOLY MINER and TIME GOES ON.
