**Footnotes**

KALOOKAN BOSS stalked the early pace racing three wide, began to advance upon entering the backstretch while racing on the outside, took command entering the final turn and quickly opened a clear advantage, and widened in the stretch. SUPER STEVE broke sharply, dueled for the early lead racing one from the rail, vied along the rail entering the second turn and down the backside, and while unable to match strides with KALOOKAN BOSS in the final furlong, battled gamely to hold on for the place. WINDY DAY away alertly, vied for the early lead from along the rail, eased off the pacesetters entering the second turn, rallied four wide on the final turn and just missed getting up for the place. NORTHWAY away well, pressed the early pace while racing three wide, dueled two wide into the second turn and down the backstretch, but began to fade in the final furlong. AZTEC RULER raced two wide throughout and never threatened. GREAT PRINCE chased three wide throughout, but was never a factor. BOBBY HANDY reared at the start, unseating his rider. Following the running of the race the stewards conducted an enquiry into the start of the race. After review the stewards declared BOBBY HANDY to be a non-starter, and ordered a full refund
