### Footnotes

BURJ DUBAI never far back, gaining from between horses, gained the lead from three wide on the backstretch, prevailed being ridden out. SEMINOLE BRAVE broke sharply, pressed the pace from the inside, finished well as second best. ARKHILL trailed early, tracked the leaders from the inside, bore out in the stretch. WOOMBROOM EXPRESS broke sharply, gained command, set a pressured pace from off the rail, gave way. BANK EMBLEM away alertly and well placed, stalked the pace from off the rail, failed to menace. Following the race there was a riders claim of foul. The rider of BANK EMBLEM claimed foul against the rider of ARKHILL for interference in the stretch. After review the claim of foul was disallowed.
