Footnotes

CRY CRY CRY broke outwards leaving the gate forcing DASHING DAISY to take up sharply, tracked the early leader into the turn racing one from the rail, pressed the pace from the outside of CAMINO down the backside, took command entering the final turn and quickly opened a clear lead, and was able to hold off the late closers through the stretch. JEZEBELLE raced mid pack down the backside racing one from the rail, split rivals to commence a two wide rally entering the final turn and closed well from along the inside in the stretch drive. RANDOM HIGHS unhurried early while dropping back to trail, rallied three wide on the final turn, and closed willingly five wide through the stretch to get up for a share. NOTIS HER stalked the early pace into the backside racing three wide, posted a mild bid approaching the final turn, and finished evenly. DASHING DAISY was bumped and forced to steady sharply in the opening strides, raced one from the rail into the backstretch, rallied four wide on the final turn, but lacked the needed closing response. DEAREST PRINCESS away alertly and tracked the leader from along the inside entering the backstretch, held a striking position to the final turn before weakening. FLAME A FEU was forced to steady early when crowded leaving the gate, raced three wide into the first turn and failed to ever menace. CAMINO away well and rushed to the lead entering the first turn from along the rail, vied for command from the inside of CRY CRY CRY to the final turn before weakening. Following the running of this race, there was a jockey's claim of foul. The rider of DASHING DAISY lodged a claim of foul against the rider of CRY CRY CRY, for alleged interference leaving the gate. After review the stewards upheld the claim of foul and disqualified CRY CRY CRY from first and placed her fifth
