**Footnotes**

UNDO IT stalked the leaders from along the inside entering the first turn, tracked the pace from the two path down the backside, rallied one from the rail entering the final turn and quickly assumed command and drew clear. DANNY'S CHANT away alertly and dueled for the lead one from the rail entering the first turn, held a narrow advantage from the outside of VICTORIOUS SPIRIT in the run down the backside, was tackled by UNDO IT entering the final turn, was unable to match strides with that rival through the final furlong but battled gamely to hold the place. VICTORIOUS SPIRIT away well and vied for the early lead from along the rail entering the first turn, assumed a tracking position from along the inside down the backside, was no match for the winner but closed willingly through the stretch. FINALLA BLOSSOM stumbled at the start , allowed to settle off the early pace racing one from the rail into the first turn, rallied two wide entering the final turn and closed four wide through the lane. EL CIERVO unhurried early while dropping back to trail, rallied along the inside approaching the final turn, was forced to steady sharply entering the turn when in tight quarters, and never fully recovered. REVELLING broke sharply and tracked the leaders three wide into the first turn, rallied three wide through the final turn but needed more of a closing response in the stretch. LOTS OF CASH stalked the early pace racing one from the rail, advanced along the inside mid way down the backstretch but faded in the late stages. Following the running of this race there was both a stewards inquiry as well as a rider claim of foul. The rider of EL CIERVO lodged a claim of foul against the rider of FINALLA BLOSSOM for alleged interference entering the final turn. After review the stewards dismissed the claim of foul and made no change to the original running order.
