### Footnotes

FINALITY PHILLY away alertly and close up, chased the leaders from three wide, rallied and gained the lead in the late stretch, won driving. VYING TY GRR broke sharply, assumed command, set the pace, drew clear on the backstretch, gave way. JUNGLE LILY slow early, gaining from off the rail, rallied on the two path and finished well. MY BAILOUT never far back, gaining from three and four wide, weakened in the stretch. VICTORIOUS VYE away alertly and well placed, saved ground, was outrun. MISS CURRENT SEA trailed for the first half mile, showed little and was not a threat. DELTA BOUQUET broke sharply, pressed the pace from off the rail, was through early and gave way. PAT'S BID broke sharply, allowed to settle, showed little and failed to menace.
