FINALLY KRUISIN well placed, saved ground for the first mile, off the rail, to rally from three wide, gained the lead on the final turn, bore in on the upper stretch. MILITARY DEPUTY well placed, tracked the leaders from off the rail, rallied from three wide, closed and just missed. NUMAANY broke sharply, chased and pressed the pace setter, gained the lead at the mile and a quarter, bumped on the upper stretch, gave way. MOSCATO broke sharply, assumed command, set the pace, gave way. KALOOKAN BOSS trailed for a mile and a quarter, made a late gain. HARLEM unhurried early, stalked from off the rail, put in a mild rally, failed to menace. Following the race there was a stewards enquiry and a riders claim of foul. The rider of FINALLY KRUISIN claimed foul against the rider of NUMAANY for interference on the upper stretch. After review the claim of foul was disallowed.
