WHAT A BLURR broke sharply, pressed the pace from the outside, gained the lead from between horses on the backstretch, prevailed driving. AVENGING KAT broke sharply, gained command from the inside, set a pressured pace, gave way and was second best. PROMISE ONE broke sharply, pressed the pace from three wide on the first turn, allowed to settle, chased, rallied on the rail for on gain in the stretch. ENTREGADA broke slowly, trailed, gaining from four wide, weakened in the stretch. SOCORRO COUNTY never far back, stalked the pace, put in a mild bid from four wide on the final turn to gain a minor share. STORM FORCAST away alertly and close up, made a middle move from three wide, gave way. GALICA in the middle of the pack, stalked the pace from the inside, was through after five eighths.
