PRETTY MEADOW broke sharply, assumed command and drew clear, was well rated, led throughout and was ridden out through the stretch. SUMMER SYMPHONY in the middle of the pack, gaining on the inside, rallied on the rail down the stretch and was second best. STORMENTED broke sharply, well placed on the rail, stalked the pace, weakened in the stretch. SEE ME THROUGH away alertly, well placed from off the rail, stalked the pace, rallied from three wide off the backstretch, finished well. KARIS MAKAW stumbled badly at the start, steadily advanced from three and four wide, weakened in the stretch. SOCORRO COUNTY broke sharply, allowed to settle on the inside, stalked the pace, failed to menace. LA BELLE FLEUR unhurried early, showed little and was not a factor. GALICA was slow early and trailed throughout.
