COUNTESS ISADORA away alertly and close up, chased the leaders from the inside, swung five wide into the stretch, was up in the final strides, driving. TECOLOTE broke sharply, gained command, set a pressured pace, gave way. DINA LIGHT broke sharply, pressed the pace from between horses, four wide in the stretch, weakened. WANDERINGSTARFIRE hustled along and four wide on the first turn, pressed the pace from three wide, was outfinished in the stretch. SWEET ELEVIV away alertly, allowed to settle, failed to menace. FLAMES ABLAZIN unhurried early, showed little and was not a threat. I'M A VIXEN TOO broke sharply, three wide on the first turn, was through early and dropped back. Following the race there was a riders claim of foul. The rider of DINA LIGHT claimed foul against the rider of TECOLOTE for interference in the stretch. After review the claim of foul was disallowed.
