Footnotes

DIANA'S LEGACY bobbed at the start, chased three wide approaching the first turn, was forced to steady off heels entering the turn, tracked three wide down the backside, and rallied three wide on the final turn, and wore down INCLUDE THE GRAND in deep stretch. INCLUDE THE GRAND chased the pacesetters four wide into the first turn, opened a clear lead mid way down the backstretch, held her clear lead into the stretch but was unable to hold off DIANA'S LEGACY in deep stretch. PRINCESS RAINIER allowed to settle early racing three wide into the backstretch, rallied five wide on the final turn and was up to grab a share. DELTA BOUQUET allowed to settle off the early leaders while racing four wide, rallied four wide on the final turn and improved her position without ever threatening. DE VILBISS away well and dueled for the early lead from just off the rail, took command entering the first turn and held a clear advantage into the backstretch, lost the lead nearing the final turn and faded. HER TIME TO SHINE chased the pacesetter five wide into the first turn, advanced four wide down the backstretch to gain a striking position but weakened over the final furlong. EPICUREAN saved ground throughout while racing along the rail, but was never a factor. MCGILL away alertly and stalked the dueling leaders into the first turn, was forced to steady briefly mid way through

the turn, tracked from along the inside down the backstretch but faded over the final furlong. MY BAILOUT broke sharply and vied for the lead from along the rail entering the first turn, was forced to check briefly when in tight at the rail mid way around the turn, and steadily retreated in the run towards the final turn. BEAUTIFUL BREEZE trailed throughout.
