A Scale Weight Stakes for Three Year Olds and Upward Fillies and Mares. By subscription of \$200 to accompany the nomination due on Wednesday, October 6, 2004. \$1,250 to enter and \$1,250 to pass scratch time. With \$125,000 added and an additional \$25,000 from the Breeders' Cup Fund for Cup nominees only. All Hastings Entertainment Inc. purse money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Breeders' Cup Fund monies correspondingly divided providing a Breeders' Cup nominee has finished in an awarded position. Any Breeders' Cup Fund monies not awarded will revert back to the Fund. Preference will be based on lifetime earnings as recorded by The Daily Racing Form at time of entry. In a case where horses have identical earnings, preference will be given to the Breeders' Cup eligible horse. Scale Weights: 3 year olds 121 lbs, Older 124 lbs.

SEE ME THROUGH broke sharply, assumed command, being well rated, led throughout, drew clear on the final turn and won driving. SUMMER SYMPHONY away alertly and unhurried on the inside, angled out to rally from four wide on the final turn, finished well as second best. YOU AND NELLY unhurried early, rallied from four wide around the final turn and down the stretch, was next best. STORMENTED broke sharply, chased the winner from off the rail, weakened in the stretch. SOCORRO COUNTY unhurried early and three wide, five wide on the backstretch, put in a bid from four wide and weakened. LA BELLE FLEUR away alertly and well placed on the inside, was through after a half. DEFRERE'S IMAGE broke slowly, trailed far back, made a late rally but was not a threat. PALACE ROSE broke sharply, pressed the pace from off the rail, gave way after three quarters. BRAVE MISS unhurried early, showed little and was not a factor. AUNT SOPHIE away alertly, stalked the pace from a three wide trip, four wide on the backstretch, gave way after three quarters. ICE GIRL in the middle of the pack, gaining on the two path, was through after three quarter.
