**Footnotes**

FLASHY GREEN was unhurried early while off the pace, bid three wide near the quarter pole, floated into mid-track for the drive, caught the leaders inside the eighth pole then edged past late. LAY LINE FORCE pressed the pace two wide into the lane, bid outside the eighth pole to get on near even terms then was outfinished by the winner while clear for the place spot. GIBSON set the pace along the inside, was pressured into the lane by the runner-up then weakened inside the sixteenth pole. BID'S REWARD chased the pace form the two path into the lane and lacked a response. BE ME tracked the pace along the inside, bid in late turn then tired in the drive. LIEPERS FORK was never a factor while in the two or three path. MOUNTAIN JUSTICE broke in air at the start, spotted the field several lengths and lost all chance. FREDRIK THE GREAT was finished early while in the three path.
