BANDI'S GAL broke alertly to gain an immediate lead, cleared into the turn, remained on a clear advantage into the lane and held while being kept to the task. VAN GOGO GIRL chased the winner throughout while in the two or three path through the turn and into the lane and could not gain on that one while clearly second best. MOTION TO DISMISS trailed for half while off the inside, fanned widest for the drive and finished with good energy although belatedly. SHE'SNHIDEF bid through the three path through the turn then weakened in the drive. TUDIE POP was never a factor while in the three path through the turn. SEMINOLE LADY broke out and bumped rival at the start, tracked the pace from the inside through the turn then tired in the lane. PRETTY PAULINE was bumped at the start and never contended. MS GIAVONNA was very wide into the first turn, rejoined the field to contend, was dropping back through mid-turn when bolting to the outside and galloped home to be distanced.
