SEA OF ENQUIRY was well placed early, angled into the five path in the turn, edged clear late in the stretch and held in the final stages. JEMARU was unhurried early, swung into the six path in the turn, rallied in the stretch but did not have enough late. STROLL WITH ME stalked the pace early, angled into the three path in the turn, led in the stretch and lost whip inside the eighth pole then faltered late. PRAYER ANSWERED chased the pace early, angled into the four path in the turn and weakened late. MY PAL RICHIE angled into the five path in the turn while no threat. PLEASE INCLUDE ME was never a factor. WHENTHEDEALINSDONE was through after a half. DOUG set the pace early, while on the inside into the turn and soon retreated.
