PRESIDENT'S WOMAN trailed for half while in the three path, angled widest into the lane when gaining momentum then finished willingly to be up in time from mid-track. TAYLOR'S GOLD was unhurried early, moved four wide through the turn, came into mid-track for the drive, was bumped near the eighth pole and finished with good energy to gain the place spot. MOTION vied along the inside into the turn, was put in tight and checked in mid-turn, dropped back to chase the pacesetter into the lane then was gaining late when outfinished by the top two. LA ESCONDIDA raced along the inside throughout and was gaining late. STAY FOR THE STORM set the pace into the lane, remained on an open lead with an eight to go then faltered. STORMIN NICOLE chased the pace along the rail then lacked a closing bid. BOLD PEAKS raced in the two or three path into the lane then lacked a closing response.
