STILL IN FRONT was far back early, fanned into the seven path in the turn then rallied in the stretch and edged past the leader in the final stages. SPICE OF LIFE was unhurried early, angled into the five path in the turn then made a bid and led late in the stretch but was caught in the final strides. AMANDA'S DREAM was back early, angled off the rail into the turn then made a bid in the stretch but weakened late in the drive. LITTLE CORDELIA was unprepared and hopped at the start then dueling early, angled off the rail into the turn then was tired in the stretch while drifting in and out in the late stages. UPTOWN JUSTICE stalked the dueling leaders early, angled into the four path in the turn and faded late in the stretch run. RACE ME swung into the six path in the turn while no threat. A BENE C angled into the three path in the turn then made a bid in the stretch but was empty late. CHILI RED PEPPER bobbled and bumped at the start. NORA ROSE was through after a half. SHEZA HOT MESS had early speed then folded up. DAYTIME DREAMS had brief speed then folded up.
