**Footnotes**

FAITH IN ACTION was unhurried early, angled into the four path in the far turn then rallied in the stretch and drove past the tiring leader late under a steady drive. FLORIDA'S QUIXOTE stalked the pace early then dueled for a time, angled into the three path in the turn and led in the stretch but faltered late in the drive. SHARP LAD was back early, angled off the rail into the far turn and moved up while no threat. MAYBE SATISFIED was reserved early, angled into the four path in the far turn and improved position in the stretch. BLAZIN BULLEY angled into the five path in the far turn while no factor. BEST PROSPECT angled off the rail into the far turn with no rally in the stretch run. BIG BOOTY dueled early from the inside, stayed on the rail into the far turn and gave way in the stretch. NIGHT WING swung widest into the lane and never menaced. BRIDGEONTHERIVER was through after a half. TOUR WITH JO had brief speed then retreated.
