FUTURITY TRIAL Heartland Futurity Trial - Quarter Horse

FOR REGISTERED QUARTER HORSES, TWO YEARS OLD. Weight 122 lbs. By subscription of \$200.00 to nominate to the trials, and an additional \$300.00 to start in the trials. Nomination and starting fees to be added to The Heartland Futurity purse. Top ten fastest qualifiers to trials remain eligible to The Heartland Futurity. This race will be run as many times as deemed necessary. Fields will be limited to ten starters. If less than 13 nominations, trials will be cancelled and moved to a final stake, with the horses having the highest lifetime earnings remaining eligible. Assistant starters will be supplied to competitors. A current negative coggins, health certificate dated within 30 days if shipping from out of state, and proof of equine herpes vaccination within the last 6 months must accompany the horse. A LATE NOMINATION FEE OF \$5,000.00 WILL BE ACCEPTED IN THE FORM OF CASH, OR CERTIFIED CHECK UP TO 9:00 AM THE DAY OF ENTRY TO THE TRIALS.
